Rules & Regulations

- Potential exhibitors must send in (3) images of setup/product before application is approved. Images can be sent along with application to Rachel@TheFarmNC.com.
- Booth Sharing is NOT permitted.
- Exhibitors may not extend any items beyond the dimensions of their booth. Aisles must be kept clear and free of all exhibitors and/or products.
- Exhibitors may not pin, staple or attach anything to the show curtains. Hooks will be provided if you need any signage hung up. Booths will consist of 8' black backdrops and 8' side dividers.
- No refunds will be given on any money paid.
- No early breakdown - no exceptions. Breakdown will not be permitted before 9PM on Saturday night.
- Payment is due at time of booth reservation (cash or check preferred). There will be a 3.5% fee incurred on vendors wishing to pay by credit card. Checks are to be made out to Farm Production Company and mailed to 215 Batten Road Selma, NC 27576. There will be a \$25 charge on all returned checks.

Farm Production Company cannot prevent you from becoming exposed to, contracting, or spreading COVID-19 while attending our event. It is not possible to prevent the presence of the disease at events open to the public.
